VETERANS ARE 1.5X more likely to get prostate cancer

### CDC's National Comprehensive Cancer Control Program (NCCCP) Funding in Missouri:

- Increase the number of high-risk men who receive prostate cancer screening.
- **Promote** informed decision-making regarding prostate cancer early detection.
- Offer culturally sensitive education to the public regarding prostate cancer.
- **Increase** health care providers' awareness of current cancer screening guidelines and follow-up recommendations.
- **Analyze** health insurance coverage for cancer screening/early detection and determine gaps and need in coverage via the legislative activities.
- Identify geographic disparities to increase utilization

### (continued from previous page) CDC's National Comprehensive Cancer Control Program (NCCCP) Funding in Missouri:

Section 376.1250 RSM o 1999. Cancer screening, health insurance coverage required, when, types.

- **1. All individual and group** health insurance policies providing coverage on an expense-incurred basis, individual and group service or indemnity type contracts issued by a nonprofit corporation, individual and group service contracts issued by a health maintenance organization, all self-insured group arrangements to the extent not preempted by federal law and all managed health care delivery entities of any type or description, that are delivered, issued for delivery, continued or renewed on or after August 28, 1999, and providing coverage to any resident of this state shall provide benefits or coverage for:
  - (2) A prostate examination and laboratory tests for cancer for any nonsymptomatic man covered under such policy or contract, in accordance with the current American Cancer Society guidelines; and
- 2. Coverage and benefits related to the examinations and tests as required by this section shall be at least as favorable and subject to the same dollar limits, deductible, and co-payments as other covered benefits or services. History: (L. 1999 H.B. 191 ¤ 1, A.L. 2011 H.B. 388)
